Community Composting for Green Spaces Grant Program

\$510,000 (FY 2021-22) for Tribes in California

- Result in the creation of new, improved, or expanded community composting sites
- Enhancement of green spaces by providing trees, compost, and gardens
- Increase composting capacity throughout the state on lands owned, managed, or stewarded by tribal community members
- Reduce organic materials in landfill creating methane



Greenhouse Gas Reduction (GHG) Loan Program

\$2,500,000 available

The GHG Reduction Loan Program provides funds to support new or expanded infrastructure projects:

- Composting and anaerobic digestion facilities
- Facilities that manufacture fiber, plastic, or glass waste materials into beneficial products.

Loans may fund the following:

- Machinery and equipment, including vehicles or other “rolling stock”
- Working capital
- Real estate purchase or improvements
- Refinancing of onerous debt

Loan applications are accepted continuously, and loans will be awarded subject to availability of program funds.

Recycling Market Development Zone (RMDZ) Loan Program

\$21,000,000 available

Facilities must use post-consumer or secondary-recovered waste feedstock generated in California.

Loans may fund the following:

- Machinery and equipment, including vehicles or other “rolling stock”
- Working capital
- Real estate purchase or improvements
- Refinancing of onerous debt
