About the Program

AHSC is part of the California Climate Investments (CCI), a statewide initiative that puts billions of Cap-and-Trade dollars to work

- Reduce Greenhouse Gas Emissions
- Strengthen the Economy
- Improve Public Health and Safety
- Impact Disadvantage Communities

Projects Combine:

- Green Affordable Housing (50% of application)
- Near Public Transit
- Zero-Emission Vehicles & Transit Amenities
- Active Transportation Infrastructure
- Urban Greening (Trees, gardens, water infiltration)



Program Objectives from SB 862

- Reducing air pollution
- Improving conditions in disadvantaged communities
- Supporting or improving public health and other co-benefits
- Improving connectivity and accessibility to jobs, housing, and services.
- Increasing options for mobility, including the implementation of the Active Transportation Program
- Increasing transit ridership
- Preserving and developing affordable housing for lower-income households

What does AHSC fund?

- **Affordable Housing Developments**
 - Rental Projects (loan)
 - Homeownership Projects (grant)
- **Housing-Related Infrastructure**
 - Infrastructure improvements as required as Condition of Approval
 - Factory built housing components
 - On-site energy storage (battery arrays)
- **Sustainable Transportation Infrastructure**
 - Transit, Bikeways, Sidewalks, Crosswalks, Curb Ramps
- **Transportation-Related Amenities**
 - Bike Parking, Bus Shelters, Urban Greening, Lighting
- **Programs (3 years)**
 - Active Transportation Programs, Transit Ridership Programs, Air Pollution Reduction programs, Workforce Development Programs, Low-Income Car Share, Tenant Legal Counseling, AHD resident support

Impacts: 200+ Projects Across California



More than \$4 billion invested over 8 rounds



Over 22,000 affordable homes



Reduction of 5.7 million metric tons of CO₂





Factory-Built Housing (FBH) Pre-Development Program

October 2023: SGC Resolution 2023-02 to Support Energy-Efficient FBH to meet the State's Housing, Climate, and Equity Goals

- Build new/expand energy-efficient FBH manufacturing facilities in California
- Support projects eligible for and applying for federal assistance

June 2024: FBH Pre-Development Pilot Program

- \$12 million available for FBH manufacturing facilities
- Support applicants applying for US DOE LPO Title 17 Clean Energy Financing Loan



San Leandro Senior Apartments

Affordable housing built on former parking lot across from San Leandro BART Station. Reduced 22 weeks of construction time. Funded by AHSC.

FBH Landscape Assessment

Aim

Identify barriers and opportunities for FBH deployment in California

Process

- Public request for information
- Webinar
- Direct engagement with FBH market participants
- Review of existing literature

Deployment Barriers

- Lack of standardized building codes across jurisdictions and levels of government
- Local zoning restrictions
- Misaligned financing timelines
- Distance from factories to job sites
- Negative perception / Low market acceptance

Impacts

- Time and cost increases
- Limited ability to deploy at scale

FBH Landscape Assessment

Opportunities

- Focus on deployment of FBH (demand side), as well as development of factories (supply side)
- Requires a mix of interventions:
 - Education to increase awareness of opportunities, affordability, and benefits
 - Technical assistance for local governments (planning, zoning, codes, siting, installation)
 - Pilot projects to demonstrate feasibility and return on investment
 - Coordination with existing local and regional housing and economic development efforts



Project Types

Land Use Planning Grants – that support the development of local and regional land use policies and economic development strategies to protect critical agricultural land.

Acquisition Grants – To permanently protect important agricultural land under threat of conversion.

Capacity Grants – to expand organizational capacity to develop agricultural conservation acquisition projects.




Timeline

Other SGC Programs

Transformative Climate Communities (TCC): Empowers the communities most impacted by pollution to choose their own goals, strategies, and projects to reduce greenhouse gas emissions and local air pollution.

Community Resilience Centers (CRC): Funds new construction and upgrades of neighborhood-level resilience centers to provide shelter and resources during climate and other emergencies. The program will also fund year-round services and ongoing programming that build overall community resilience.

Tribal Capacity Building provides funding and technical assistance to California Native American tribes, enhancing their staff capacity to advance tribes' climate-related work. The goal of the Pilot Program is to help tribes develop long-term capacity to secure funding and implement tribal-led climate solutions.
